The Board discussed setting a rate of reimbursement for Sheriff's fees. A request was made for information from the surrounding counties to see what they are paying on sheriff's fees. This will be brought to a future meeting to discuss again.

The Board discussed the meeting dates for the balance of the calendar year. Most were satisfied with the current date of the fourth Tuesday of the month so it was agreed to continue with that date for the Board meeting.

Moved by Phil Bootsma, seconded by Linda Swanson to approve a letter of support for Seasons Center for a Certified Community Behavioral Health Center planning grant application. Motion carried by all ayes.

A proposed addition to the Region's bylaws was presented. It was tabled to a future meeting so the legal counsel could review it.

Moved by Phil Bootsma, seconded by Linda Swanson to authorize the Chair to sign a contract with Turning Point/Plains Area Mental Health for Residential Crisis Services for Fiscal 2017. Motion carried by all ayes except Ed Noonan who voted nay.
