Kim Wilson reviewed the Fiscal 2015 Region's Annual Report with the Board. Moved by Phil Bootsma, seconded by Ron Graettinger to approve the Fiscal 2015 Annual Report for the NW Iowa Care Connections Mental Health and Disability Services including the amendment to include additional information regarding training to be included on page 8. Motion carried by all ayes.

Mark Behrens left the meeting at 2:09 p.m.

Employment Initiative – Barry Whitsell gave a revised Employment Initiative outcomes proposal overview. Moved by Phil Bootsma to approve this proposal for the employment initiatives with the data collection process presented in the proposal by the service providers as a pilot project beginning December 1, 2015 through June 30, 2016, seconded by Ron Graettinger. Motion carried by all ayes.

Targeted Case Management – Clay County has completed provider enrollment applications for MCOs. O'Brien and Osceola County are in the process of completing their applications. Some MCOs want to do in house case management/care coordination while others may be interested in contracting with local agencies.

Kim Wilson gave information regarding the Sheriff Probation Service Coordination Pilot Project policy and procedures, which is in process of review and implementation. Updates regarding Regional Service Coordination was discussed.

Iowa Code information was shared within the regional attorney's legal review of the billing procedure of sheriff transportation costs for civil commitments. The Board directed Kim Wilson to compose a letter to advise of a proposed updated reimbursement policy and billing procedures that will be reviewed and approved at the next meeting.

ISU Extension – Evidence Based Supports for Families – programs for caregivers to provide tools for supports.

Project Alert – Kim is still working to get together with each of the county sheriffs and other county staff throughout the region to get this in place.
